JOINT STATUS REPORT

Pursuant to the Court's April 2, 2025 Electronic Scheduling Order, Plaintiffs Marissa Collins, James Burnett, Karyn Sanchez and A.I. (collectively, "Plaintiffs") and Defendants Anthem, Inc. and Anthem UM Services, Inc. (collectively, "Defendants") jointly provide the Court with the following status report.

Following extensive good-faith, arms-length negotiations and a private mediation, the parties have agreed in principle on the central terms of a class settlement to resolve this case. They are finalizing a term sheet reflecting the main settlement terms, and do not anticipate obstacles to the execution of the term sheet.

The parties will then memorialize the class settlement in a written agreement and Plaintiffs will prepare a motion for preliminary approval of the class settlement, proposed notice to class members, a proposed plan of allocation, and related materials.

The parties propose that Court set a deadline of May 30, 2025 for Plaintiffs to file the motion for preliminary approval and accompanying materials.
